NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

1. The name of the Trust shall be "MALANKARA SYRIAN CATHOLIC TRUST".

2. The registered Office of the Trust shall be at Maria Nagar, Padi, Madras -600 050 or any other place which the TRUSTEES shall deem fit from time to time.

3. The term "TRUSTEES" shall mean and include the Founder Trustees for the time being of the "MALANKARA SYRIAN CATHOLIC TRUST". The Administrator of the Archdiocese of Trivandrum until an Archbishop is appointed, and as and when an Archbishop is appointed, the Archbishop, the Chancellor of the Archdiocese of Trivandrum until the Archbishop of Trivandrum appoints a Vicar General and then the Vicar General, and the Procurator of the Archdiocese of Trivandrum will be the Managing Trustee, Assistant Managing Trustee and the Treasurer respectively of this Trust. Their successors in office will become automatically the Managing Trustee, Assistant Managing Trustee and the Treasurer respectively in the Malankara Syrian Catholic Trust.

4. The Objects of the Trust are:

i. To establish and administer Colleges, Schools, Hostels, Libraries, Technical Institutions such as i) Engineering, Aeronautics, Aviation etc., ii) Medical and Paramedical, iii) Agriculture, Sericulture, Horticulture, Pisciculture, Goat farming etc., iv) Management Studies, Business Administration, Marketing and Hotel Management, Law, Tourism etc. promoting industries for bringing high quality professional education to the talented and economically weaker section of the society.

This is also established for providing educational opportunity preferably for Malankara Catholic Christian Community in accordance with the rights of the minority community guaranteed in the Constitution of our Country and in case, if the required Malankara Catholic Christian Community pupils are not available to give opportunity to any pupil from other Christian Community or from any other religion.

ii. To unite together the members of the Malankara Catholic Christian Community for the development of their physical, intellectual and spiritual well being, to inspire them with Christian ideals, to co-operate with other sections of the Christian Churches and other organizations working for the welfare of the nation and to stimulate movements in furtherance of the Kingdom of God.

iii. To promote hostel facilities for students and others.

ii. The income and property, whensoever derived, shall be applied solely towards the promotion of the objects of the Trust as set forth in the Trust deed and no part thereof shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise howsoever by way of profit to the Trustees or otherwise PROVIDED that nothing herein contained shall prevent the payment in good faith of remuneration to any officers or servants or employees or Trustees or to any member thereof or other persons in return for services actually rendered to the Trust.

2. The Board of Trustees shall comprise of the Managing Trustee, Assistant Managing Trustee, the Treasurer, the Secretary and five members, who shall be in the position of Trustees and not as beneficiaries. The Board of Trustees at present shall consist of the following persons as Office bearers:

- 1. The Administrator of the Archdiocese of Trivandrum - (His Excellency / Bishop Lawrence Mar, Ephraem) / Archbishop of Trivandrum. - Managing Trustee

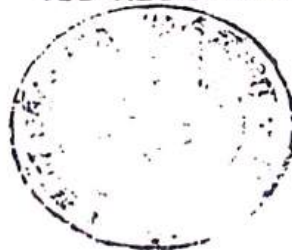

The members of the Board of Trustees shall hold office at the pleasure of the Managing Trustee. Any vacancy arising in the Board of Trustees by reason of death, resignation, removal or for any other reason shall be filled up by the Managing Trustee and his decision in this matter shall be final and binding. In the case of death or resignation of the Managing Trustee, the person holding the charge of the Archdiocese of Truvandrum shall be the Managing Trustee.

**7. MANAGEMENT**

i. The Managing Trustee shall manage the College and other institutions through the Board of Trustees composed of not more than 10 members constituted for the purpose and with the assistance of an Educational Agency constituted in each of the Institutions now under the Management of the Trust. The members of the Educational Agency shall be the Managing Trustee. The Educational Agency of each Institute or any members thereof shall hold office at the pleasure of the Managing Trustee who shall cause such Agencies to be constituted from time to time in consultation with the Board of Trustee. The decision of the Managing Trustee shall be final and binding in this matter.

**8. POWER OF THE BOARD OF TRUSTEES**

i. The Managing Trustee shall have power to appoint such members of Standing Committees, Secretaries and other Staff as are reasonably required for the efficient discharge of the work of the Trust.

ii. The Board of Trustees shall be entitled to frame and prescribe, from time to time, rules and bye-laws and regulations for carrying out of the objects of the Trust and for all other matters incidental to and connected with the carrying out of the Trust and also to modify, alter or amend such rules, bye-laws and regulations within the frame work and in conformity with the objects of the Trust.

9. POWERS OF THE MANAGING TRUSTEE

i. The Managing Trustee shall manage the College and other institutions through the Board of Trustees composed of not more than 10 members constituted for the purpose and with the assistance of an Educational Agency constituted in each of the Institutions under the management of the Trust. The members of the Educational Agency shall be nominated by the Managing Trustee. The Educational Agency of each College shall hold office at the pleasure of the Managing Trustee who shall cause such Agencies to be constituted from time to time in consultation with the Board of Trustees. The decision of the Managing Trustee shall be final and binding.

ii. The Secretary and the Treasurer shall be nominated by the Managing Trustee.

iii. The Board of Trustees shall meet normally twice a year for the transaction of the business. In case of any difference of opinion over any matter, the decision of the Managing Trustee shall be final and binding.

iv. Five members shall constitute a quorum. Any member who absents himself for three consecutive meetings, without leave of absence, shall be deemed to have forfeited his membership of the Board of Trustees.

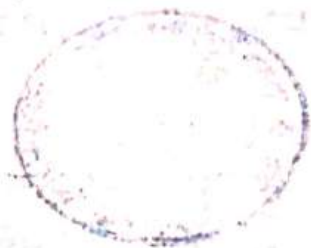

v. All property, including buildings, ground, furniture, books and invested capital is vested with the Managing Trustee and no contract, debt or other obligations affecting the Trust shall be binding unless sanctioned by the Managing Trustee.

10. DUTIES OF THE OFFICERS

i. The Managing Trustee or the Assistant Managing Trustee shall preside at all Meetings of the Trust.

ii. The Secretary shall keep the minutes of all meetings of the Trust. He shall determine the place and date for the meeting of the Board of Trustee and prepare the agenda in consultation with the Managing Trustee.

The Secretary shall operate upon Bank account.

The Secretary shall submit to the Treasurer and Board of Trustees monthly and yearly statement of accounts.

At the beginning or end of each year the Secretary shall prepare and present to the Treasurer and Board of Trustee an annual budget for its approval.

iii. The Treasurer shall have charge of all the money of the Trust. He shall invest the whole or portion of the funds in any bank or banks as shall be authorised by the Board of Trustees.

The quorum for the meeting shall be five. Any member who absents himself for three consecutive meetings, without leave of absence, shall be deemed to have forfeited his membership of the Board of Trustees.

ii. The Managing Trustee shall be the Chairman for all the meetings of the Trust. In his absence, Assistant Managing Trustee shall be the Chairman of the Meeting and shall preside over the same.

iii. In case of any difference of opinion over any matter, the decision of the Managing Trustee shall be final and binding.

iv. The Board of Trustees shall be entitled to frame and prescribe, from time to time, rules and bye-laws and regulations for carrying out the objects of the Trust and for all other matters incidental to and connected with the Trust; and also to modify, alter or amend such rules, bye-laws and regulations within the frame work and in conformity with the objects of the Trust.

## 12. GENERAL BODY OF THE TRUSTEES

### 1. ANNUAL GENERAL MEETING

i. The official year of the association shall be April 1st to 31st March.

ii. The annual meeting of the Trust shall be held each year ordinarily before the end of May at which the Annual Report of the Board of Trustees together with statement of Accounts, duly certified by the Auditor/Auditors appointed by the Board of Trustees shall be presented. The appointment of the Secretary and the Treasurer shall be made as soon as possible after the annual meeting and they shall continue in Office until their successors are appointed.
