18. AMENDMENTS

The constitution may be amended or altered by votes of not less than 3/4th of the members present and voting at any regular or special meeting, provided previous notice of not less than 14 days of such alteration or amendment has been given to the members.

Clause 4 is amended as follows:

"4" The objects of the Trust are:

"To Establish and administer Colleges, Schools, Hostels, Technical Institutions such i) Libraries, and Engineering, Aviation etc., ii) Medical Aeronotics, Horticulture, Paramedical, iii) Agriculture, Sericulture, Pisciculture, Goat farming etc., iv) Management studies, Business Administration, Marketing and Hotel Management, Law, Tourism etc. promoting industries for bringing high quality professional education to the talented and economically weaker section of the society. To establish deemed universities to fulfill the above said objects of providing higher education.

The following objects is to be added as sub clauses II, III, and IV as against the old sub clause starting from II, III and IV

- ii.To establish, develop, maintain, run hospital, dispensaries, maternity homes, child welfare centres and or such other charitable institutions in India for the benefit and use of the general public.
- iii. To establish maintain or grant aid to homes for the aged, orphanages or other establishmeths for the relief and help to the poor, needy and destitute people, orphans widows and aged persons.
- iv. To establish, maintain or grant aid to institution for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing and other help.

The original sub clause II of Clause 4 is to be deleted and the sub clauses starting from III will be renumbered as V and onwards.
