NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

- The name of the Trust shall be "MALANKARA SYRIAN CATHOLIC TRUST".
- The registered Office of the Trust shall be at Maria Nagar, Padi, Madras -600 050 or any other place which the TRUSTEES shall deem fit from time to time.
- 3. The term "TRUSTEES" shall mean and include the Founder Trustees for the time being of the "MALANKARA SYRIAN CATHOLIC TRUST". The Administrator of the Archdiocese of Trivandrum until an Archbishop is appointed, and as and when an Archbishop is appointed, the Archbishop, the Chancellor of the Archdiocese of Trivandrum until the Archbishop of Trivandrum appoints a Vicar General and then the Vicar General, and the Procurator of the Archdiocese of Trivandrum will be the Managing Trustee, Assistant Managing Trustee and the Treasurer respectively of this Trust. Their successors in office will become automatically the Managing Trustee, Assistant Managing Trustee, Assistant Managing Trustee and the Treasurer respectively in the Malankara Syrian Catholic Trust.

To establish deemed Universities to fulfill the above sold objects of providing higher education. This is also established for providing educational opportunity preferably for Malankara Catholic Christian Community in accordance with the rights of the minority community guaranteed in the Constitution of our Country and in case, if the required Malankara Catholic Christian Community pupils are not available to give opportunity to any pupil from other Christian Community or from any other religion.

- ii. To unite together the members of the Malankara Catholic Christian Community for the development of their physical, intellectual and spiritual well being, to inspire them with Christian ideals, to co-operate with other sections of the Christian Churches and other organizations working for the welfare of the nation and to stimulate movements in furtherance of the Kingdom of God.
- iii. To promote hostel facilities for students and others.
- iv. To secure funds for the purchase of land, erection of building, and other expenditure necessary for the promotion of the objects of the Trust.
- v. To employ Secretaries and other staff as may be required for the work of the Trust.
- vi. To purchase, take on lease, or hire or otherwise to acquire and hold and also to sell, transfer or lease any movable and immovable property or any rights or privileges therein for the furtherance of the objects of the Trust.
- vii. To construct, alter or keep in repair any buildings required or used by for the Trust.

Vili. To invest monies in such manner as may be decided from time to time by the Managing Trustee, who manages the Colleges and other allied institutions through an Educational Agency constituted for the purpose.

- ix. To work in co-operation with any other Trust or Association or Society having objects altogether or in part similar to those of the Trust.
- x. To borrow or raise money, with or without interest, upon banking account or otherwise by the issue of bonds, promissory notes, debentures or securities, mortgages and other obligations on behalf of the Trust as will be decided by the 'Board of Trustees' if and when necessary.

Any vacancy arising in the Board of Trustees by reason of death, resignation, removal or for any other reason shall be filled up by the Managing Trustee and his decision in this matter shall be final and binding. In the case of death or resignation of the Managing Trustee, the person holding the charge of the Archdiocese of Truvandrum shall be the Managing Trustee.

7. MANAGEMENT

i. If upon dissolution or winding up of the Trust there remains, after satisfaction of all debts and liabilities, any property whatsoever, the same shall not be applied to or distributed among the members of the Trust or any of them but shall be transferred to some institution/institutions or Trusts having objects similar to the objects of the Trust in any manner to be determined by the managing trustee.

18. AMENDMENTS

The constitution may be amended or altered by votes of not less than 3/4th of the members present and voting at any regular or special meeting, provided previous notice of not less than 14 days of such alteration or amendment has been given to the members.

19. INDIAN TRUST ACT

In all other matters, the Trust shall be covered by the relevant Indian Trust Act or Statutary Modification thereof or any other related law for the time being in force.

Clause 4 is amended as follows:

- "4" The objects of the Trust are:
- 1. To establish deemed universities to fulfill the above said objects of providing higher education.

The following objects is to be added as sub clauses II, $\,$ III, and IV as against the old sub clause starting from II,III and IV

- 11.To establish, develop, maintain, run hospital, dispensaries, maternity homes, child welfare centres and or such other charitable institutions in India for the benefit and use of the general public.
- iii. To establish maintain or grant aid to homes for the aged, orphanages or other establishmeths for the relief and help to the poor, needy and destitute people, orphans widows and aged persons.
- iv. To establish, maintain or grant aid to institution for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing and other help.

The original sub clause II of Clause 4 is to be deleted and the sub clauses starting from III will be renumbered as V and onwards.
